Dear Teatown friends,

For many decades, Teatown has connected people to nature. Never in our history has this community service been more needed or essential than it was during 2020 and 2021. In the past year, record numbers of visitors have come to Teatown to find peace, hope, and tranquility at our 1,000-acre preserve. We are proud of all we have done this year to welcome and connect with visitors in person and virtually.

Our 2020-2021 fiscal year required us to adjust constantly and invent. Despite the pandemic, we found ways to maintain a connection with our community and push ahead with our long-term goals. We revised in-person events and programs and created virtual and hybrid versions. We adapted to COVID-safe models for our "Grow Wild Outside" program for under-resourced children, the Teatown Science Academy (TESA), and our signature EagleFest and PlantFest community events. Our Education Team successfully ran all four sessions of our Natural Science Summer Day Camp with more than 300 children – half our usual enrollment - participating in safe, active, and educational fun at Teatown.

Our Stewardship Team advanced several important habitat restoration projects in Teatown's meadows, forests, and wetlands this year, including the completion of a major restoration within Wildflower Woods that enhances the health of Teatown Lake.

Our Visitor Center finally re-opened to the public in June, a truly joyful day for the Teatown community.

Last, but certainly not least, we made excellent progress in the quiet phase of the "Teatown Campaign for Future Generations." With an aspirational goal of \$14 million, this capital campaign will fund much-needed enhancements and improvements to our preserve, lakes, dams, classrooms, and public spaces.



Our science and stewardship mission is to conserve our region's biodiversity, while creating an environment for exceptional educational opportunities.

We are focusing on restoring habitats across the preserve.

Teatown's Stewardship staff and volunteers have restored approximately two acres of habitat at three different project sites across Teatown's preserve. This includes a 0.5-acre wetland in Wildflower Woods to mitigate stormwater runoff from Teatown's parking lot, adding

one acre of grassland habitat to connect 11 acres of meadow at Cliffdale, and planting more than 100 oak trees to replace invasive Tree-of-Heaven along Spring Valley Road.

Volunteers have contributed at least 800 hours to land stewardship, helping plant more than 7,000 plants as a part of our restoration work. Other volunteer projects

included assisting with invasive species removals and trail work to maintain Teatown's 15 miles of hiking trails.

The Teatown Environmental Science Academy (TESA) entered its ninth year and successfully hosted 11 students from 10 different area high schools. Research projects were as diverse as ever, ranging from understanding land use history and its effect on invasive plant abundance to studying biodiversity of Teatown's lakes, streams, and wetlands. This year's TESA was co-taught by Pace University professor, Dr. Matthew Aiello-Lammens, and Teatown's Director of Science and Stewardship, Dr. Danielle Begley-Miller.


We offered more internships to students and early career professionals than ever before. We hosted six new interns in our Stewardship department, increasing our capacity for high-impact projects. Interns were responsible for helping monitor wildlife populations, maintaining newly planted restoration areas, and removing invasive species in key areas across the preserve.

Education programs

Teatown educators met the challenge presented by the worldwide COVID-19 pandemic by researching, developing, producing, and sharing virtual field trips with local schools. Our Distance Learning videos were sent to 10 Westchester County districts, including Somers, Armonk, Ossining, and Mt. Vernon. Students learned about indigenous peoples of the Hudson Valley in "Keepers of the

Earth," met Teatown's Animal Ambassadors, and watched as we boiled maple sap into syrup. Many students engaged with Teatown educators in live Q&A sessions after viewing the videos.

In March we joyfully began welcoming back small groups of students from private schools that were able to visit Teatown.

No Child Left Inside (NCLI)

Through generous support we were able to develop virtual

programs to meet the needs of schools to supplement their hybrid learning year. Approximately 1,100 students from Mt. Vernon, Peekskill, Ossining, and Yonkers participated.

Public Programs

Although Teatown took the difficult step to cancel Summer Camp 2020, the education staff was active in many other ways. Educators traveled off-site to lead outdoor activities for Yorktown and Croton Parks and Recreation, Ossining Library, and participated in the Ossining school district's virtual Summer Explore and Learn program.

Our voyage into the virtual world included Backyard Wildlife, a bi-monthly series featuring topics in conservation and sustainability, an interactive map for EagleFest that was viewed by more than 2,000 people, and Virtual Animal Ambassadors, a drop-in visit by raptors which enlivened many a meeting or Zoom party!

We began offering a robust array of public programs in the fall, including Little Tree Huggers, Nature Detectives, Explorers Club, and more. Our Women Take to the Trails program attracted a dedicated cohort of hikers who explored all corners of Teatown, from autumn leaf drop, through the winter world, and on into spring bloom! Our talented staff developed and produced Enchanted Forest, a magical

Halloween experience for families that is sure to become an annual event.

In June, Wildflower Island reopened for volunteer led guided tours, which continued throughout the bloom season.

Ossining Nature Girls

Despite the challenges of hybrid learning, intrepid young women from Roosevelt School in Ossining visited Teatown weekly during our Nature Girls afterschool program that encourages girls to embrace their inner scientist.

Grow Wild Outside

The Grow Wild Outside (GWO) kindergarten after-school program was reimagined into Grow Wild @ Home for the Ossining school district's virtual Summer Explore and Learn series. Children met three days per week with a Teatown educator and investigated their neighborhood trees and animals. Inspired by the summer success, GWO went virtual for the school year. Over the course of 24 weeks, 89 children participated; many stayed with the program for the full year. Nature Discovery Kits – activity packets with everything needed for each activity, including books, magnifying lenses, bug boxes, and tweezers - were distributed to the GWO students. Activities included simple experiments, journaling exercises, and active games. Utilizing



introduced to each topic, shared their thoughts, ideas, and results, and most importantly, connected with their peers. They enjoyed the social connection so much that one kindergartner suggested the Meet stay open so they could continue socializing!

Environmental Leaders Learning Alliance (ELLA)

Expanding our Impact in the Community

Building on the success of our partnership with the Town of Ossining, Teatown helped the Town of Yorktown implement a municipal food scrap recycling program and drop-off site at Downing Park, bringing Westchester County one step closer to its waste reduction goals.




