Third Annual Teatown Hudson River EagleFest Photography Competition

The contest begins on Sunday, January 1, 2023 All submissions must be received by Tuesday, January 24, 2023, at 11:59pm ET.

The winner will be announced on Saturday, February 4, 2023, at EagleFest and live on Teatown's social media channels.

Participants must submit their work as a high-res .JPEG, .TIFF, or .PNG. The winning photograph will be featured on Teatown's website (www.teatown.org) and social media. First-place, second- place, and third-place winners will receive birding binoculars generously provided by Zeiss Sports Optics. A fourth-place runner-up will receive a gift card provided by L.L. Bean.

Requirements:

Please send submissions to <u>EagleFest@teatown.org</u> with the subject line "EagleFest 2023 Photography Competition Submission." Only one (1) submission allowed per person. Winners from the 2022 EagleFest Photo Competition are not eligible to participate.

Please save your file using the LastName_FirstName format.

In the body of your email, please include:

- 1. Title of the photograph
- 2. Type of bird
- 3. Where it was taken
- 4. Any technical or interesting information about the photo (e.g., Did you have to climb a tree to get the shot? Walk on an icy pond? We want to know!)

Terms and conditions:

- 1. Photographs will be accepted only from the original photographer.
- 2. Photographer must be the sole author and the owner of the copyright for any photo entered.
- 3. Photographers must have sufficient permission of any recognizable persons appearing in the photograph to be able to grant rights to display the photographic submission online or in printed materials.
- 4. Photographers retain ownership of all copyrights. However, by submitting an image for entry in this contest, you automatically give Teatown Lake Reservation permission and rights to store, display, and use the image, its thumbnails, and your name as the photographer, indefinitely in any non-commercial media without notification or compensation.
